### Notice Regarding Receipt of Large-Scale Order

As disclosed in the “Notice Regarding the Acquisition of Fixed Assets (GPU servers Equipped with NVIDIA B200)” dated July 4, 2025, Datasection Inc. has entered into a purchase agreement for a set of 625 GPU servers equipped with 5,000 NVIDIA B200 units, to be installed at the planned AI data center in Osaka Prefecture (hereinafter referred to as the “AI Data Center”).

We are pleased to announce that, through our business partner NowNaw Japan Co., Ltd., we have indirectly entered into a large-scale service usage agreement with a customer who is one of the world’s largest cloud service providers (hereinafter referred to as the “Customer”) for the AI Data Center services, as detailed below.
