Notice Regarding Changes in Major Shareholders and the Largest Major Shareholder

Datasection Inc. (the “Company”) hereby announces that there have been changes to its major shareholders and the largest shareholder among its major shareholders, as set out below.

On 14 August 2026 (with the reporting obligation dates being 6 August 2026 and 12 August 2026), the Company confirmed changes to its major shareholders and the largest shareholder among its major shareholders as a result of Earth Elements Capital Co., Ltd. (the “Earth Elements Capital”) submitting amended Large Shareholding Reports (Change Reports No. 10 and No. 11) to the Kanto Local Finance Bureau. As announced in the “Notice Regarding Changes in Major Shareholders and the Largest Major Shareholder” dated 14 November 2025, all voting rights relating to the shares held by Earth Elements Capital have been delegated by First Plus Financial Holdings PTE. LTD. (“First Plus”) with respect to the exercise of such voting rights and other related rights.
